## Service Plan Options for Special Care Residence Assisted Living Residents



New Horizons at Marlborough is dedicated to ensuring that residents receive the assistance they need in the privacy of their own home and in a manner that respects and maintains their independence and dignity. The majority of personal care at New Horizons is provided by Mary Ann Morse Healthcare Corp., which maintains an on-site office with 24-hour staffing. Under the supervision of a nurse, personal care assistants help residents with activities of daily living, which may include bathing, dressing, grooming, basic housekeeping, self-administered medication management, and incontinence management, as described in the following plan options.

Programs are based on an average time for typical delivery of care. All service plans are subject to additional fees when extra staff is warranted to meet an individual's needs.

#### **Service Plan Reviews**

Assisted living services fall under the guidance of the multi-disciplinary team for case and care management. Each service plan is tailored to meet the specific requirements of the resident, is updated as the resident's health or situation changes, and is reviewed regularly, as outlined below.

- **30-day Review:** A review meeting is typically held **30** days after the start of the service plan to verify its appropriateness.
- **Semiannual Review:** Review meetings are held twice per year to verify ongoing appropriateness in accordance with the regulations of the Executive Office of Aging and Independence.
- Ad Hoc Review: The resident or the resident's family may request a service plan review at any time by calling the Mary Ann Morse program coordinator to schedule an appointment.
